Context – About my business

I provide instrumental tuition to individual students. At the time of this assessment, I currently have 91 active student and approximately between 5 and 10 students awaiting registration at any given time. Whilst a risk assessment for COVID-19 is **not required** for R Hammond's Piano Lessons; one has been created to ensure that, wherever possible as many risks of COVID-19 transmission are reduced as much as possible. All students are either taught online or in-person (when allowable by law) as per the student's preference. In-person teaching takes place in a music studio, separate from my home but on the same site. The music studio has its own entrance and exit, again which is separate from my home but on the same site. The music studio has built-in hand washing facilities, which were available before the pandemic and students are always required to wash their hands before playing the grand piano situated in the same room. I have and will continue to provide both online lessons and in-person lessons as required to meet all student needs and preferences. I intend to continue the offer a blend of in-person tuition and online tuition, in accordance with the preferences of my students and subject always to the advice, guidance or legislation of the UK/Scottish/Welsh/Northern Irish governments.

How this risk assessment was carried out

Whilst it is widely known, understood and accepted that the risk of transmission will never be 0, this risk assessment strives as much as possible to make the risk of COVID-19 transmission low.

This risk assessment is based on the method and principles of the Health & Safety Executive (HSE)'s COVID-19 risk assessment, including advice about coronavirus and safe working here: <https://www.hse.gov.uk/coronavirus/working-safely/index.htm> and has been compiled based on the advice issued by HM Government. The aim of this risk assessment is to identify how COVID-19 could spread in my 'in-person' teaching environment, and to identify methods to stop the spread of the virus. This assessment reflects any relevant official government guidance for safe working during the pandemic. This risk assessment does not cover any risks associated with students who have online lessons at home, it is for the student in this scenario to ensure their own safety, in-line with the latest Government guidance around COVID-19.

I identified hazards by walking around my working space, mapping entry and exit procedures and movement around the building, noting ventilation options within my space, considering instrument and equipment cleaning procedures and whether any items are shared, taking note of additional risks associated with certain musical activities, e.g. singing, and reflecting on travel and how my students would get to my teaching space. I also considered those who may be considered to be vulnerable who also live in my home, and also what measures to deploy if any COVID symptoms appear in me, my students or other members of my household.

I will update this assessment periodically considering changes in government guidance or restrictions.

Prior to COVID-19

Prior to COVID-19 R Hammond's Piano Lessons practice has always held high hygiene systems to make sure that the environment is safe for both the student and the teacher. This risk assessment builds on this already high level of hygiene.

During the COVID-19 Pandemic

During the COVID-19 pandemic (starting on the 20th March 2020) all lessons in the UK were conducted online to provide students with consistency, continuity in their study and above all, putting the safety of students and their families at the heart of all decisions. Online lessons have been widely adopted and welcomed across the sector, and in the case of R Hammond's Piano lessons there was a 98% adoption rate.

The current situation – Since April 2021

The Incorporated Society of Musicians (ISM) have now informed me that students, both adult and children, are able to return to in-person lessons or can choose to have their lessons online, or a mixture of the two as they decide, in-line and in accordance with the latest Government regulations. However, for students attending in-person lessons, there will be an expectation placed upon them to uphold and follow the below risk assessment fully to ensure the safety of myself, my family, their family and other students. Students who show any symptoms of COVID-19 (confirmed COVID-19 or not) **MUST NOT** attend any arranged in-person lessons and instead their lesson will be conducted online until they are advised that they are no longer required to isolate.

It is presumed that many students will choose to continue their lessons online. This is because in many cases, students live too far away from the practise (e.g. another city or country) and online lessons will provide the least possible risk of transmission whilst allowing them to continue with their tuition.

Online lessons will continue to be provided as an option indefinitely, in addition to in-person lessons, for students who would like to continue learning in the comfort of their own home. Student's can also mix and match between in-person lessons and online lessons at home to suit their needs as much as they wish, this adjustment to the provision of lessons will be reflected in all new block booking tuition agreements from 2021 onwards.

From May 2021, all students who wish to attend lessons in-person will be permitted to do so provided they follow procedures as set out below the UK Government and or ISM advise that they are no longer necessary.

Students who attend in-person lessons accept there will never be a 0 level of risk but instead a significantly reduced risk of contracting COVID-19.

Procedure for in-person lessons

Prior to the day of the booked lesson	Students wishing to have an in-person lesson should inform their teacher by text only. This must be agreed by the teacher the day before their booked lesson. This will allow appropriate PPE to be planned and prepared.
On the day of the in-person lesson	On the day of the lesson, students who have COVID-19 symptoms or who have been asked to self-isolate by the Government's test and trace service should instead stay at home and have their lesson online , as they have done during the pandemic. In-line with HM government guidance, if a student attempts to attend an in-person lesson with COVID-19 symptoms (that were known prior to the lesson) or who fails to observe the safety measures in full, their lesson will not be provided and no reimbursement will be made for that lesson.
Arrival to the in-person lesson	<ul style="list-style-type: none"> • The student will be required to arrive at their allotted appointment time and wait in their vehicle until they receive a text message or a visual indication they can enter the studio room. They should not bring unnecessary materials, except their music books, to their lesson. They must wear a suitable face covering. • The student will be escorted into their lesson by the teacher who will be wearing a face shield and mask. The teacher will open all doors and close all doors. The student may scan the COVID QR code with the NHS App if they wish (not essential). • Parents or accompanying adults must remain in their vehicle to collect the student after their lesson (as normal) and must not wait outside the lesson room in the carport area or on the driveway. They will not be permitted to enter the room or sit in any lessons as it is not possible to socially distance with more than two people in the room. If they wish to contact the teacher, they should do so using telephone, email or text message.
